_____ I declare that the artwork I submit is original in design and production (no prints or giclee).

_____ I agree to abide by the hanging requirements:

Framed art: Neat backing, D-hooks with taped off wiring, and wall bumpers or felt protectors.

Canvases: Must be 1 1/2" gallery wrapped, painted on sides or if a lesser width, the canvas is to be framed.

Frames: All frames must be in excellent condition. All art: Tracking information on back of art.

_____ I agree to assist the Circuit Chair Person with the hanging, removing, changing out of my art. If I can not be there, I will seek a buddy artist to deliver and assist the Circuit Chair Person in my place.

_____ I understand I must be able to change out my art on the set date. If I am unable to do so, I agree to leave it until the next change out date. I also understand and agree that only the Circuit Chair can make arrangements with the proprietors of the business for exceptions to this rule.

_____ I will be responsible for meeting with the buyer to collect the fee and transfer the art.

_____ I will be responsible for paying the tax on the retail amount of the sale.

_____ I hold the exhibition site and OAG free of liability for any damage, loss, or theft.

_____ I commit to a year's participation at this location. In the case of a sale and the periodic change outs during the year, I will have several replacements available for immediate change out. I understand that should I withdraw my artwork; my spot would be lost and an additional \$10.00 would be charged for the privilege of rejoining. Regardless of the circumstances, I will arrange with the Circuit Chair on dates/times that we will be removing and/or replacing my art.
